1. We refer to Resolution 4A (the "**Resolution**") proposed to be passed at the annual general meeting of Asia Standard International Group Limited ("**ASI**") to be held on 4 September 2024 ("**AGM**").
2. The Resolution, if passed, would grant to the directors of ASI a general mandate to allot, issue and deal with shares in ASI not exceeding 20% of the issued share capital of ASI as at the date of the passing of the Resolution.
3. We hereby unconditionally and irrevocably undertake to The Sai Group Limited and ASI that at the AGM we will vote in favour of the Resolution and procure that all companies controlled by us which hold shares in ASI will vote in favour of the Resolution.

This undertaking shall be governed by and construed and take effect in accordance with the laws of The Hong Kong Special Administrative Region of the People's Republic of China.
